A total of 8,360 candidates are contesting the ongoing Lok Sabha elections, the highest since 1996, according to an analysis of official data. In the 2019 polls, there were 8,039 candidates, and in 1996, a record 13,952 candidates were in the fray for 543 seats of the Lower House of Parliament. The 2024 general elections are being held in seven phases, with five rounds of polling completed. The sixth and last rounds will be held on May 25 and June 1, respectively. Counting of votes will be taken up on June 4.

The fourth phase of the elections held on May 13 had the highest number of candidates in the fray, 1,717 in 96 parliamentary constituencies in 10 states and Union Territories (UTs). The first phase held on April 19 had 1,625 candidates in 102 constituencies in 21 states and UTs, according to Election Commission (EC) data.

There were 1,198 candidates in the second phase on April 26 in 89 constituencies across 13 states and UTs, 1,352 candidates in the third phase on May 7 in 94 constituencies in 12 states and UTs and 695 candidates in the fifth phase on May 20 in 49 constituencies across eight states and UTs.

मतदान के वास्तविक एवं अंतिम आंकड़ों में भारी अंतर, लोगों की शंका दूर करे निर्वाचन आयोग : कांग्रेस

नई दिल्ली, (भाषा)। कांग्रेस ने बुधवार को मतदान के वास्तविक समय के आंकड़ों (रियल टाइम फिगर) और निर्वाचन आयोग द्वारा जारी अंतिम आंकड़ों के बीच बड़े अंतर को लेकर सवाल उठाया और कहा कि देश में मतदाता इससे चिंतित हैं। पार्टी के मीडिया विभाग के प्रमुख पवन खेड़ा ने एक वीडियो जारी कर यह दावा भी किया कि यह अंतर करीब 1.7 करोड़ मतों का है। उनका कहना है कि जो लोगों के मन में शक पैदा हुआ है वो जायज है और इस शक को निर्वाचन आयोग को दूर करना चाहिए। खेड़ा ने कहा, मतदाता मतदान के चार चरणों के दौरान निर्वाचन आयोग की गतिविधियों को लेकर चिंतित हैं। पहले, आयोग को मतदान के अंतिम आंकड़े सामने लाने में 10-11 दिन लगते हैं और फिर वास्तविक समय के आंकड़ों और अंतिम आंकड़ों के बीच अंतर आता है। वोट का अंतर इतिहास में कभी नहीं हुआ। कांग्रेस महासचिव जयराम रमेश ने एक्स पर पोस्ट किया इस अंतर के हिसाब से प्रत्येक लोकसभा सीट पर 28,000 मत की वृद्धि होती है, जो कि बहुत बड़ा नंबर है। यह अंतर उन राज्यों में सबसे ज्यादा है जहां भाजपा को अच्छी-खासी सीट के नुकसान होने की गुंजाइश है। 'आखिर यह हो क्या रहा है?'
